# **The proposed creation of a unified umbrella organisation to represent Shi'a Muslims in the United Kingdom**

## **Preamble and Introduction – What is all this about?**

The creation of a united body to represent the interests and welfare of all Shi'a Muslim organisations within the U.K. has for a long time been the aspiration of many. The aim of such a formation would be to unify, develop and enhance the Shi'a Muslim community such that its members recognise and aid one another, becoming an integral community that is able to contribute not only to its own progression, but also to that of society in general.

Following a series of meetings held during 2006 in London and Birmingham between various Shi'a Muslim organisations, which included 'ulema, youth, intellectuals and professionals, it was proposed that now was the time to form an establishment which would **not** represent Shi'a Muslims by ethnicity, political inclination or nationality but by our ultimate identity: followers of Ahlul Bayt (a.s.). The organisations that supported these meetings include: Abrar Foundation, Al Khoei Foundation, Al Khoei Islamic Centre, Al Mahdi Institute, Alulbayt (a.s.) Foundation, Bilal Cultural Centre, Council of European Jamaats, Husayniyyah Rasool A'zam - London, Imam Ali Foundation, Imam Hussein Foundation, International College for Islamic Studies, Islamic Centre of England, Islamic College for Advanced Studies, Islamic Thought, Islamic Unity Society, Islamic Universal Association, Jamaat Ulema, Majlis e Ulama, Markaz al Tafkeef Islami, Rasool A'zam – Birmingham, Shabab al Mahdi, The Saviour Foundation, The World Federation of KSIMC and the World Ahlul Bayt Islamic League. This list is by no means final, and continues to grow each day.

In order to further the above aim, and building upon previous work, an Interim Working Committee for the formation of a Shi'a Muslim Council was created at a meeting held in Birmingham on Sunday 18<sup>th</sup> June 2006. A full list of the committee members can be found overleaf. The aim of this committee is simple; to engage in a consultation process, region by region, with all Shi'a Muslim organisations, and to work with them towards the eventual formation of a Shi'a Muslim Council. The ethos behind this paper is to gain your views on the formation of such an umbrella organisation, and to ensure that the formation of such a body is achieved through a fair, representative and electoral process. This consultation document has been sent to all Shi'a Ithna-Asheri organisations and interested individuals within the Shi'a Ithna-Asheri Muslim community in the U.K. for their valued input. Indeed, by consultation their views can be heard and given due recognition.

In the following pages, you should find several sections, each one pertaining to an important issue relating to the formation of an umbrella organisation. Please complete each and every section.

We look forward to your suggestions, input and involvement, which we regard as most valuable. Indeed with mutual cooperation, dedication and perseverance we shall together be able to bring forth the true spirit of Islam and noble teachings of Ahlul Bayt (a.s.).
